Dear business partners of DUAP AG

DUAP strives to fulfil all legal requirements at all times. This applies also the RoHS Directives EU 2011/65 & 2015/863. Our supplier are instructed, for every order, to adhere the legal regulatories for environmental- and industrial-safety.

Directive 2011 / 65 / EU (RoHS)

DUAP is aware that both directives limits the use of specific substances in electric and electronic appliances and products. It applies to the following six substances:

- lead (Pb): 0.1%
- mercury: 0.1%
- cadmium (Cd): 0.01%
- hexavalent chromium (Cr6+): 0.1%
- polybrominated biphenyls (PBB): 0.1%
- polybrominated diphenyl ethers (PBDE): 0.1%

following substances have been added in the guideline (EU) 2015/863 dd. 31 March 2015

- Bis(2-ethylhexyl) phthalate (DEHP): 0.1%
- Butyl benzyl phthalate (BBP): 0.1%
- Dibutyl phthalate (DBP): 0.1%
- Diisobutyl phthalate (DIBP): 0.1%
- Perfluorobutane sulfonic acid (PFBS) and its salts: 0.1%
- Diisohexyl phthalate: 0.1%
- 2-methyl-1-(4-methylthiophenyl)-2-morpholinopropan-1-one: 0.1%
- 2-benzyl-2-dimethylamino-4'-morpholinobutyrophenone: 0.1%

Declaration of conformity

With this document DUAP confirms, that all products manufactured by DUAP AG, does not contain any of the 10 hazardous substances in concentrations above the specified limits, mentioned in homogenous materials. Exemptions do not apply.
